- ___ **High-Resolution color copy of the data page of your passport**, with at least **six months remaining** validity beyond the travel date. The actual passport should have at least two blank pages for stamping by the Immigration officer. If you need help securing, renewing, or updating your passport, please contact GenVisa at **(800) 845-8968** for requirements and fees.
- ___ **One (1) recent passport photo(s)** per person (approx 2x2) – no home photos / no photocopies.
- ___ Zimbabwe application will be submitted on your behalf by GenVisa staff online, using the information provided on the **E-Visa order form** (attached).
- ___ **Copy of driver's license**, state issued ID, or major utility bill (Water, Gas, Electric, Sewage) for the most recent month, showing the applicant's name and current address.
- ___ Copy of **round-trip airline tickets or itinerary**, or letter of confirmation from the tour operator.
- ___ Prepaid self-addressed first-class mail envelope if you wish to receive a physical copy of your E-Visa
- ___ **Payment:** a check or money order payable to GenVisa in US Dollars and drawn on a US bank.

Complete and *return this entire form* with the requested materials – use a traceable form of mail.

Important: Do not send your passport/materials more than 4 months prior to your trip date.

Processing generally takes 3-4 weeks. If you need your passport **within 21 days:** add \$45 per person for expedited service. If you are departing **within 10 days:** add \$75 per person for express service. *Consular fees and forms are subject to change without notice.
